ACC Updates/Discussion

- Fire Hardening Code & MCC Fence Requirements
 - The ACC request that prompted this discussion has chosen to use cedar with a fire-retardant stain which meets the city code.
 - Any requests for a metal fence will be handled on a case-by-case basis. Metal fences installed to date have been decorative to enclose a small area not as a border fence.
- Entry & Path Clean up
 - Gerry called the city and they cleaned up the entry into the neighborhood by killing the weeds.
 - The HOA areas have continued to be maintained on a regular basis by a contractor.
- City Property Mowing
 - The city property around the entrances into the neighborhood has been mowed once the Parks and Recreation department was called.
- Review any ACC submissions (7 reviewed and approved.)
 - Installation of a cedar fence on the wings of the house.
 - Replacement of garage doors and exterior brick between garage doors.
 - \circ $\;$ Installation of a solar powered attic vent mounted to the roof.
 - Two requests for outdoor landscaping.

 - A front door replacement.
 - Installation of vines on a HOA fence to match the neighbor.
